## Community Engagement

Stakeholder meetings were scheduled. These meetings included teachers, classified, parents that represented EL, SWD, and Foster, Low Income were involved in discussions as to what types of learning opportunities and mitigation strategies they would like the funds to be used towards to address the academic impact of the loss of instructional time and other activities they would like to see implemented by the LEA. The stakeholders provided feedback and prioritized the opportunities that meet the needs of the students of our district. Among these opportunities items discussed were summer school, before-school extended learning, after-school extended learning, targeted intervention during the school day, and off-campus learning centers. Families were surveyed to gather input as to the types of extended learning opportunities and social-emotional opportunities they felt would meet the needs of their children. Survey feedback on these opportunities was used to rank the priorities from most important to least important. Families expressed a need for students at all grade levels to be provided with additional enrichment programs such as Music, ARTS, Afterschool Learning, intervention, Science, Arts, Field Trips to help extend their learning. These programs will assist in mitigating students' lost learning opportunities to connect their learning with real-world experiences. They also expressed a need for social-emotional support. Social and emotional learning (SEL) is essential in addressing the whole child in terms of education and human development. Feedback from the DELAC group also focused on providing additional staff support to assist with closing the achievement gap and to provide support for the mental well-being of the students. The DELAC group also wanted to see

additional professional development for all staff in areas of social-emotional intelligence. They wanted to see additional protective measures such as PPE, campus supervision, and campus beautification, and outside shade structures to be able to spread the student population out safely. We will use a variety of data to identify the needs of our students. Teachers will be conducting assessments at the grade levels k-4 to identify students with the greatest needs. These assessments will be utilized by our partner Sunny days to provide an Expanded Learning Opportunity program to make up for the learning loss due to Covid-19.

A description of how the development of the plan was influenced by community input.

Summary of Feedback provided by specific stakeholder groups:

Out of 119 responses, 75.2% were from Parents or Guardians, 18.8% were from teachers, 13.7% were from community members, 6% were from support staff, 4.3% were from students and the remaining were from campus administrators, counselors.

The three areas that they believed were the most important priorities as the district responds to the impact of COVID-19 were additional staff to provide support for academic learning loss, students' social and emotional well-being, and additional instructional resources for students and teachers.

A minimum of 20% of ESSER III funding is required to be used towards academic learning loss. The 4 areas that ranked the highest from responses from surveys were focused intervention programs for specifically identified populations such as students at risk of dropping out of school, students with disabilities, English Learners, and others. Second, was Extended before and after school tutoring programs. The third was focused on intersession tutoring programs, fourth was a tie between professional development and acquiring evidence-based instructional materials to aid in intervention efforts. Lastly, survey responses addressed 3 additional areas that they believe will best address our student's needs as they return to in-person instruction were additional Social-emotional well-being such as counseling and social work activities ranking the highest, following technology needs to include device upgrades, software programs, and hotspot access. Lastly, Safety considerations include upgrades to district facilities.

The following aspects of the LCAP, Expanded Learning Opportunities Grant Plan, and the ESSER III Expenditures Plan were influenced by community input:

The before and after school program is being offered through our Sunny Days partnership and is being offered at no cost to families who qualify for free and reduced. An expanded learning program thru Sunny Days that provides additional enrichment opportunities is being offered at Meadowlark Elementary school. Chromebooks will be provided to all students enrolled in AADUSD. Hot spots will be provided to families that choose an independent study and have zero to limited access to the internet. Additional staff and hours will be provided to paraprofessionals to provide additional academic support for students. We are exploring options to bring additional enrichment programs to the district such as LA Arts Collective, AVID, PBIS, Cultivating Creative Minds, Wyman Teen Connection Project, Gaggle, etc. We are exploring partnering with AVC for a dual enrollment offering for Vasquez High School Students. Campus supervision will be addressed utilizing our instructional aide classification. Additional professional development will be provided to classified and certificated staff. AADUSD is looking to add a Counselor, Psychologist, and Social Worker to be able to address Social Emotional Learning and Mental Health support, and resources to students and families that will be contingent upon categorical funding. Additional school supplies for students in grades K-12 to support AADUSD personalized learning initiatives, to increase student engagement, and to improve enrichment opportunities. Additional PPE, facilities upgrades, school spirit materials to address safety and social-emotional support.

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
  - Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
  - Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;



- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
