### Supt report for August 25, 2022:

This evening I will be covering the following strategic initiatives: Student Achievement and Community Engagement.

#### **Student Achievement:**

Kudos to our wonderful certificated and classified staff for ensuring a very smooth first day back to school. They worked diligently to welcome back our students, staff, and families. We look forward to a successful and safe 22-23 school year. The opening of schools was very smooth at all three sites. Positive energy during my walkthrough of classrooms and offices.

Actual enrollment as of today, 1,008. Today we had 986 students physically at school (ADA), 16 students verified absent today, and only 6 unverified absences as of today. School front offices are making calls to the unverified absences. We are holding strong with overall enrollment numbers! With an increase of enrollment comes larger class sizes, primarily at Meadowlark and High Desert.

- My team and I are assessing class sizes daily. A review of staffing allocations will occur on Tuesday, 8/30 as it is common practice at all districts once the enrollment numbers (and no-show students) are solidified. We will be looking into current staffing allocations as it reflects the larger class sizes, primarily at ML and HDS. Most districts do wait for early October, commonly referred to as norm day.

- My team and I also provide our guidance and input when it comes to the secondary schedule as part of checks and balances. For instance, we cross-

reference teaching assignments to credential authorizations. We intervene if there is a misalignment of a teaching assignment. This happened to be the case at HDS.

## **Community Engagement:**

Prior to the start of the new school year, we held our annual Welcome back breakfast at Vasquez High Scholl on August 16th. The focus of the kick-off provided our community and staff an overview of our signature programs, to include AVID, Alludo, and Paper. A team development activity was facilitated by counselor Ms. Ballesteros. Our marketing campaign was highlighted as well.

# **COVID Report:**

 $\cdot$  Last week there were 5 cases of COVID in the Acton-Agua Dulce surrounding area reported to DPH.

 $\cdot$  Since the first day of school we have had 10 positive cases reported and sent out over 100 close contact notifications.

 $\cdot$  Test kits are available at each school site.

 $\cdot$  Testing clinic hours are Monday's from 2:00-3:15 at the District Offices.

 $\cdot$  Our next clinic will be on August 30th from 2-4 at the District Office MPR.

 $\cdot$  Masks will not be required unless there is classroom exposure. If your student has been asked to wear a mask at school, it was because they were exposed to a COVID positive case.

 $\cdot$  OSHA still has a requirement for unvaccinated staff to be COVID tested weekly, but now they are able to conduct a self-read COVID test at home and upload it into the Primary Health Platform.

 $\cdot$  All students and staff should register for Primary Health so that they can upload home test results in the COVID tracking platform.
