## Superintendent report for January 13, 2022:

This evening I will be covering the following strategic initiatives: Student Achievement, Effective Instruction and Leadership, Community Engagement, and Student Connectedness.

#### **Student Achievement:**

I did visit the new AVC class- HE 120 Stress Management on Monday, January 31<sup>st</sup>. A total of 17 students have enrolled in the class, held during period 4 at VHS. Thanks to AVC Instructor, Mr. John Livermont students were engaged as they reviewed assignments pertaining to the class. Such assignments include, a gratitude collage project and students creating their own relaxation script.

## **Effective Instruction and Leadership:**

Most recently High Desert surveyed their community of students, parents, and staff on a block scheduling proposal for the 22-23 academic calendar. Based on the results (over 51% in favor of block scheduling) a virtual town hall meeting was set up on February 3rd at 5:30 pm as well as Friday February 4th at 1:00 pm to review the proposal and answer questions form the community. I attended these virtual meetings with Principal Van Ornum. The presentation has been posted to the High Desert website as of late last week for anyone to review.

#### **Community Engagement:**

Our newly formed Shadow Day Collaborative works in unison with all three schools to provide opportunities for current and prospective parents and students to experience AADUSD programs and curriculum.

During a Shadow Day experience, students and parents will engage in activities, meet other students, and get to know staff.

We kicked off the first Shadow day event last Monday, January 31st.

On Monday, January 31st, our High Desert Hawks Soccer Teams and their families were invited to the Vasquez High School Boys' Soccer Team and Vasquez senior night. The Hawks took a team photo with the VHS Boys soccer team! We also offered up an outdoor tour of the VHS campus to High Desert families, and then Hawks cheered on the VHS Mustangs as they took on Village Christian. ## **COVID Report:**

I'd like to provide an up to date COVID report, data pulled from LACDPH.
4,360 new cases as reported to LACDPH as of February 7th<sup>th</sup> as compared to 18,822 new cases for January 25th<sup>,</sup> as reported at our last board meeting. A significant surge since our last board meeting, approximately a month ago.

The testing positivity rate, a 7-day average for the week of January 31st is at 8.39% as compared to the week of January 18<sup>th</sup> which came in at 16.61%.

We sincerely hope these numbers will keep decreasing as we move forward with the academic year.

As we may have already heard, L.A. County is looking to ease the indoor masking mandate sometime next week for folks who are vaccinated.

Having participated in a virtual meeting yesterday sponsored by ACSA (Association for California School Administrators), educators are anticipating a re-evaluation of the masking mandate by L.A. County Dept. of Public Health by mid-March. It is anticipated that the masking mandated may ease up for students in L.A. County. What those parameters might look like, we don't have any details at this time. However, I'd like to stress that we should remain cautiously optimistic and wait for final word in the upcoming weeks.
