• Makerspace initiative-

This evening we will be presented with a proposal the design and construction of a makerspace classroom intended for Meadowlark Elementary.

You might have heard of a makerspace. It's a buzzword that's been floating around for years now. But what, exactly, is it? A makerspace is a room that contains tools and other components, allowing students to enter with an idea and leave with a complete project. The best part is that makerspaces are communal. The goal is to work together to learn, collaborate, and share. Most importantly, makerspaces allow our students to explore, create new things, or improve things that already exist. Makerspace as simply a space designed and dedicated to hands-on creativity. In a makerspace, you're actually going to create some kind of product. Now it could be a digital product. It could be a physical product.

Materials found in a makerspace might look different throughout the school year, depending on the type of learning that's happening at the time. Sometimes it might include things like cardboard and tape, and other times it might consist of items like laptops, microphones, and green screens. A makerspace can take the form of a mobile cart that can be shared between classrooms, a set of stations that students rotate between, or a variety of materials and equipment that live in various parts of the classroom, accessible to students when the need arises.

We are exciting about the possible opportunity to bring this type of hands on creativity to Meadowlark. We look forward to tonight's presentation.

COVID Report:

I'd like to start off by thanking Cari Wright, our district nurse for being our guest speaker at our last Tuesday Talk with the Superintendent. Our topic of discussion along with a Q &A session revolved around health and safety protocols and updates from LA County DPH. We covered areas such as the recent lift of the masking mandate, outdoors. Quarantining guidelines, as well as a robust discussion around masking indoors. We did all agree upon the idea that the tolerance level of wearing masks for both adults and children is wearing thin. However, we did need to reiterate the fact that the indoor masking mandate has not been lifted along with the delivery of instruction still remains in-person or long term independent study as outlined in Assembly Bill 130.

Thank you to our parents and community members who participated last Tuesday.

Tonight, I'd like to share district specific stats at this time, covering the past six weeks: Our district's test positivity rate on January 7th was 28% The test positivity rate on February 4th was 20%. As of last week, the week of February 14th was at 4%

We sincerely hope these numbers will keep decreasing as we move forward.

Following the Los Angeles County Department of Public Health (LACDPH) orders, Acton-Agua Dulce USD lifted the outdoor masking requirement for students and staff on February 16th. On February 16th it was the seventh consecutive day the number of COVID-19 positive patients (hospitalizations) in L.A. county remained below 2,500, which was the benchmark metric set by LACDPH to lift the outdoor masking mandate.

As shared, indoor masking at TK-12 schools is still a State of California and LACDPH requirement. The indoor masking rule will remain in place for Los Angeles County until the county's virus transmission rate falls to the "moderate" level, as defined by the U.S. Centers for Disease Control and Prevention, and stays there for two weeks. Per the LACDPH, the county's rate is declining and, at its current pace, the "moderate" level metrics could possibly be met by the end of March. The California Dept. of Public Health officials will be meeting with county departments of public health on February 28th to review the metrics.
